You'll need to show your business is reliable so having good quality management procedures in place shows that your business is committed to providing a quality service and product. You'll give clients confidence that the work you carry out will be completed to a high standard and this can give you a competitive edge when it comes to winning tenders.

We'll want to see your business' policy statement of intent for quality management. You'll also be expected to provide evidence of any arrangements your business has in place to manage effectiveness, information and training, performance reviews, and supplier/contractor management. This could be in the form of policies, procedures, documented records, templates or meeting minutes.

According to the HSE (Health and Safety Executive), in 2022/23 35.2 million working days were lost due to work-related illness and workplace injury. Having good Health & Safety and quality management procedures can help prevent this!

Financial and business standing

Giving information about your business' financial status helps to show potential clients that your business is stable.

You'll be expected to provide evidence such as your financial and insurance details. You'll also need to cover information relating to any enforcement actions, civil or criminal court actions, investigations or claims.

Anti-bribery and corruption

You'll be expected to have an anti-bribery and corruption policy and show you take adequate steps to prevent bribery and corruption in your business. An anti-bribery policy sets out rules and regulations for how your employees should handle potential bribes. Your policy should be appropriate to the level of risk your business faces. It should include your approach to reducing and controlling the risks of bribery, rules about accepting gifts, guidance on how to conduct your business (such as negotiating contracts), and

rules on avoiding or stopping conflicts of interest. Having strong procedures in place will reduce any risks associated with corruption. It's all about keeping things transparent and above board!

With good practices in place, it will help you combat bribery and reduce the risk of it occurring in your supply chain. It also promotes an ethical culture in your business and shows you're demonstrating industry best practice.

Showing your commitment to these areas will give clients peace of mind that your business is making ethical choices. Clients will also want to reduce risk, so you'll also been seen as safer to work with.

Modern slavery

Making sure your workforce is treated fairly and is not being exploited is not only a requirement, it helps you avoid risk and educate your supply chain.

You'll need to show you have a modern slavery policy in place and the steps you're taking to help eradicate modern slavery.

Your policy statement should describe your company's activities, set out your company's intentions toward tackling slavery and show transparency in your businesses and supply chain. Remember to highlight who is responsible for the policy and publish the statement on your company website (or make it available on-demand).
